NEON: THIS WOULD INCLUDE NEONS OF ALL VINTAGES INCLUDING SRT-4'S.
THIS CLASS IS PARTICIPANT JUDGED.

PT CRUISER AND FRONT WHEEL DRIVE: THIS WOULD INCLUDE ALL PT'S, AND ALL FRONT WHEEL DRIVE MOPARS EXCEPT NEONS.
THIS CLASS IS PARTICIPANT JUDGED.

NEW HEMI: THIS CLASS INCLUDES LATE MODEL 300, MAGNUM, CHARGER AND CHALLENGERS.
THIS CLASS IS PARTICIPANT JUDGED

TRUCK AND 4X4: ALL TRUCKS, FOUR WHEEL DRIVES, AND JEEPS. STOCK AND MODIFIED.
THIS CLASS IS PARTICIPANT JUDGED.

MODIFIED RACE: MUST BE A RACE VEHICLE. OPEN HEADERS ARE ENCOURAGED.
THIS CLASS IS PARTICIPANT JUDGED.

A, B & E RESTIFIED: CLONES ARE IN THIS CLASS. RESTIFIED IS FOR CARS THAT HAVE A STOCK FLAVOR, BUT HAVE BEEN UPDATED. ANY UPDATE IS FINE (STEREO, CARB, EXHAUST, TIRES AND WHEELS, FOR EXAMPLE) BUT IT IS BLENDED IN TO HAVE A FACTORY, OR NEAR FACTORY APPEARANCE. MILD MODIFIED CARS FIT IN THIS CLASS AS WELL.
THIS CLASS IS PARTICIPANT JUDGED.

A, B AND E STOCK: JUST LIKE IT SOUNDS, STOCK, ORIGINAL OR RESTORED TO ORIGINAL, THE WAY IT WAS DELIVERED FROM MOTHER MOPAR. UP TO 3 MODIFICATIONS ARE ALLOWED, BUT IN THE CASE OF A TIE, THE ONE WITH FEWER MODS WOULD WIN.
